All candidates who have applied to the HRDD in the prescribed form for the above quota seats against Sl.No.1 to 12 and 18 to 21 are entitled to attend the counseling. Any candidate who has not applied as yet is given time to do so till 3 days before the respective counseling dates. Allotment of seats will be done on merit on the basis of marks obtained in the qualifying exam and reservation policy of the State Government as notified vide Notification No. GOS/19/2009/SCH/HRDD/108 dated 29th June 2009 .

For allotment of seats for courses at Srl Nos. 13 to 17, the candidates must have appeared for the CET 2009 in PCB and they must submit separate applications for these allied courses. Any candidate who has not applied for the allied courses as yet and has appeared for CET Examination 2009 is given further time to apply for the same within 14th July 09. Allotment of seats will be done on the basis of CET merit and reservation policy of the State Government as notified vide Notification No. GOS/19/2009/SCH/HRDD/108 dated 29th June 2009 .

NOTE: CANDIDATES ARE REQUIRED TO BRING ATTESTED COPIES OF THEIR MARKSHEETS AND ALL RELEVANT DOCUMENTS FOR THE COUNSELING SESSION. ANY CANDIDATE WHO FAILS TO ATTEND THE COUNSELING SESSION SHALL LOSE HIS/HER CLAIM ON THE QUOTA SEAT.
